DESCRIPTION

TECHNICAL

DATA SHEET

Streptavidin-HRP (NEL750) and Streptavidin-AP (NEL751) are highly sensitive detector conjugates. These conjugates bind to biotin labeled proteins in Western blot, ELISA and immunohistochemistry assays. They also bind to nucleic acids labeled with biotinylated nucleotide analogs in Southern and/or Northern blot, colony/plaque screen and in situ hybridization (ISH) assays.

When used in homologous DNA dot hybridizations with a biotin N⁶ labeled DNA probe, as little as 100 femtograms of nucleic acid are detectable in 2 hours or CDP-*Star*®Nucleic Acid Chemiluminescence Reagent (NEL601) in 5-10 minutes.

SUGGESTED WORKING CONDITIONS

The following are suggested conjugate concentration ranges for various assays. Individual conditions may require some conjugate titration to obtain optimal signal clarity.

<u>Membrane assays (e.g., Southern, Northern, Western, colony/plaque)</u>: Dilute conjugate 1:12,500-1:25,000 in 1X Phosphate Buffered Saline (PBS), pH 7.1-7.4 (e.g., Dulbecco's PBS), 0.1% SDS, 0.05% Tween-20, blocking reagent (or equivalent.

<u>Slide assays (i.e., ISH and IHC) including TSA</u>: Dilute conjugate 1:1250-1:2500 in 0.10 M Tris-HCI, pH 7.5, 0.15 M NaCI, blocking reagent (e.g., 2% sheep serum) or equivalent.

SA-AP

<u>Membrane assays (e.g., Southern, Northern, Western, colony/plaque)</u>: Dilute conjugate 1:25,000-1:50,000 in 1X Phosphate Buffered Saline (PBS), pH 7.1-7.4 (e.g., Dulbecco's PBS), 0.1% SDS, 0.05% Tween-20, blocking reagent or equivalent.

<u>Slide assays (i.e., ISH and IHC) without amplification</u>: Dilute conjugate 1:1000-1:2000 in 0.10 M Tris-HCl, pH 7.5, 0.15 M NaCl, blocking reagent (e.g., 2% sheep serum) or equivalent.

<u>Slide assays (i.e., ISH and IHC) with TSA</u>: Dilute conjugate 1:2500-1:5000 in 0.10 M Tris-HCl, pH 7.5, 0.15 M NaCl, blocking reagent (e.g., 2% sheep serum) or equivalent.

STABILITY

Streptavidin-HRP and Streptavidin-AP are stable for at least 6 months from the date of shipment, when stored at 4°C
